**Public Hearing on the Approved Budget for Fiscal Year 2017/2018 – Approval of Urban Renewal Agency Resolution 17-04 Would Adopt the Budget, Make Appropriations, and Levy Taxes**


Finance Director Susanne Baker stated the proposed budget for fiscal year 2017/2018 was reviewed on April 13, 2017 by the Urban Renewal Agency Budget Committee and was approved to be forward to the Agency for adoption. Approval of the proposed resolution would adopt the budget for fiscal year 2017/2018, make appropriations, and levy taxes. Chair Kramer opened the public hearing. No public comments were given and the hearing was closed. Board Member Kilmer moved to adopt the resolution 17-04 for fiscal year 2017/2018 adopting the budget, making appropriations, and levying taxes. Board Member Groth seconded the motion which passed with Chair Kramer and Board Members Benetti, DiNovo, Farmer, Groth, and Kilmer voting aye. Board Member Marler was absent.
