Consent Calendar

Chair Groth reviewed the consent calendar which consisted of 2a: approval of the minutes of December 16, 2014, and; 2b: acceptance of an emergency grant to repair Empire Boat Ramp crabbing/fishing pier. Board Member Kramer moved to approve the consent calendar approving the minutes of December 16, 2014 and accepting an emergency grant to repair Empire Boat Ramp crabbing/fishing pier. Board Member Shoji seconded the motion which passed with Chair Groth and Board Members Brick, Daily, Kramer, Leahy, Shoji, and Vaughan voting aye.

New Urban Renewal Business

Presentation on the Oregon Historical Railway Museum

Presentation on the Oregon Historical Railway Museum was rescheduled for the January 20, 2015 Urban Renewal Agency meeting.

Approval of an Extension of the Hollering Place Disposition and Development Agreement

City Manager Rodger Craddock stated on July 15, 2014 the Urban Renewal Agency (URA) entered into a Disposition and Development Agreement (DDA) with the Confederated Tribes of Coos, Lower Umpqua, and Siuslaw Indian Tribe for the potential purchase and development of the site known as the Hollering Place. Over the past six months the Tribe and City staff worked to negotiate an access easement, air rights easement, and a wayside maintenance agreement. The Tribe also conducted an evaluation to ensure the property was satisfactory for their intended use. Part of the evaluation included a title history search of the related properties. City Manager Craddock advised the evaluation revealed little or no evidence that the involved land was ever patented out of state or federal ownership; an additional investigation through the

Department of State Land was necessary to determine if the Division of State Lands had any claim on the property as former State owned submerged or submersible property. City Manager Craddock advised an extension of the DDA was necessary pursuant to Section 1.7.1(i) of the DDA. Board Member Shoji moved to allow the Agency Manager to authorize a sixty day extension of the existing agreement. Board Member Daily seconded the motion which passed with Chair Groth and Board Members Brick, Daily, Kramer, Leahy, Shoji, and Vaughan voting aye.
