PUBLIC HEARING

ITEM A: Amendments to the Comprehensive Plan and Zone Designation Maps #187-ZON14-075 - The applicant (City of Coos Bay) is proposing modifications to the City's Comprehensive Plan and Zoning Maps.

Chairman Marler asked if there were any objections to the Planning Commission hearing the item on jurisdictional grounds. He asked if any Planning Commissioner had ex parte contact or conflict of interest to report.

Chairman Marler opened the public hearing.

Debbie Erler read the disclosure statement.

Director Day summarized the proposed changes to the zone designation and comprehensive maps, including elimination of unused zones designations and the renaming and consolidation of other zones. He discussed the two properties that were included in a change of zone designation at the property owner's request (983 Central Avenue and 549 Bessie Street).

The Planning Commission discussed the proposed changes.

Chairman Marler closed the public hearing.

incorporated herein by reference as Attachment "A" recommend the City Council approve the proposed amendments to the Comprehensive Plan

<u>ADMINISTRATIVE</u>

Ms. Erler outlined the land use application for review at the May 12, 2015, including a Façade Improvement Grant and Architectural Design Review for the Dolphin Theater and a SPAR for a Pet Mart at 815 South Broadway.

Director Day stated the revised Development Codes should be effective July 1, 2015. He outlined the City Council Goals that would include the Planning Commission, including rewriting the "Noxious Vegetation" ordinance and adding a house boat ordinance. Director Day updated the Planning Commission on expected grants (\$25,000 and \$400,000), which would be for the Front Street area. He added that OHSU will be adding about 30 resident doctors to our area and they are looking for suitable housing.

COMMISSION COMMENTS

The Planning Commission discussed housing vacancy rates, use of upper-stories in the downtown area, and proposed changes to the noxious vegetation ordinance.

Commissioner Berg asked if the City has any solution to the sanitary sewer problems along Ocean Blvd that may be holding up commercial development. Director Day stated the issue needs to be looked at in depth before any plan can be made; everything needs to be up-sized.
