Unfinished Business:

- 299 B St - Susan Calvert. Trees planted in ROW by the middle school. Ariann spoke to the school regarding the trees in the ROW stating "they had no funds to remove the trees but may be willing to entertain removing one or two. They certainly are not thrilled at losing them as it adds protection from traffic, vehicles and children." Further discussion took place among the board members. The size of the trees is getting out of hand and will eventually cause problems. With diameters of 12 to 24-inches, perhaps taking a percentage per year and/or thinning could be something that might work.

The board recommends the property owner contact the school district superintendent to discuss Susan Calvert's concerns and see if they find a plan that is workable for both. At that time, bring the plan back to the Tree Board. Rex asked if there was a motion.

- Pioneer Cemetery – Replacing fence on west side of the cemetery and will need room. Removal will affect a Wax Myrtle and an unidentified hardwood. The Cedar & Cypress will stay. Staff recommends removal of listed trees so project can proceed.

Staff member, Jon Eck, brought back an update regarding the Pioneer Cemetery and the placement of the wrought iron fencing. The Wax Myrtles will be removed and the hardwood is a Maple and it will remain as it has historic value. Rex asked if there was any discussion or for a motion.

- John Topits Park at 324 Ackerman. Trees are leaning towards buildings and could pose threat in a wind storm. The trees were thought to be Shore Pine. Arborist recommends removal. Staff recommends the removal of the hazardous trees to protect life and property.

- Coos River Hwy & Ross Inlet Rd - Information only - Beaver have chewed through tree and tree is in danger of falling. Staff recommends to remove tree for safety consideration. This may be something to ask ODF&W to look into the beaver and the damage they leave behind. Rex explained that he is trying to get them to move down the river and away from the guardrail. He'd like to remove all six Alders from the guardrail along the Eastside corridor and leave the one Sunset Maple. Rex brought along a bag of "real chips." The board applauds the tenacity of the beaver in keeping Rex busy.

- 460 S 6th - Linda Jordan - Concern for tree shedding branches causing damage to cars or people. At site inspection, the tree has areas of rot and scars from previous lost branches and it is a difficult tree to prune. The tree has also been previously topped for power line clearance. Staff's recommendation is to remove the tree. The tree was identified to be a Birch. The tree's height was estimated to be approximately 50 feet.

tree list at the owner's expense.
