650 Anderson "After the Fact." Jon informed the board that the tree was removed because deemed a safety issue. Due to budget, the tree stump and sidewalk repair will be done at a later time.

1010 Hemlock – Roy & Christine Rickman – North of Hemlock and east of N 10th St. Request to do thinning and limbing of trees in ROW to permit wind variance and view of bay. Rex stated that the two trees in questions were actually in the median between N 10th and Hillside Ct. Past history had shown several trees planted in the median up from 1010 Hemlock and there had been a request to remove the trees for a better view. The request was denied. Over time all of the 6 trees had died and upon further investigation they were found to had been girdled but couldn't prove as not caught in the act.

MOTION: Ariann Lyons motioned to deny removal but for the city to maintain

on regular basis to thin at the bottom but not through the canopy.

DISCUSSION: Jon stated that it was on a rotation schedule to remove the height

out of the Laurel and bring it back to 6 feet

be sent to property owner of the board's findings.

Ariann expressed that she was excited to be starting work on the Tree List.

Rex shared his disappointment that there seemed to be "no teeth" in the rules the city establishes. There should have been further investigation and enforcement regarding the trees that had been blatantly girdled and eventually removed by the city. Randy wondered if it had been handled correctly. Rex would like to have seen the trees replanted as neighbors had stated that it buffered the traffic noise. Rex also stated that if they start approving the removal of ROW trees that it would open a can of worms and how are you going to prevent others.
